To enter, describe in 500 words or less how the production exemplifies green philosophy and/or practice.

Full members may nominate themselves or other financial ADG members in any appropriate category.

Associate members who do not have enough screen time to be eligible for full membership may nominate themselves and other members in the following categories only: TVC, animation, short film, music clip and directing for new media platforms.

If nominating for direction of a television series, including documentary, please choose only one episode per production.

Only one title may be entered with each entry form and accompanying fee.

Each entry must include

- a fully completed and signed form
- 4 DVD viewing copies
- proof of membership
- payment of fee or receipt of online-payment

Submissions must be postmarked no later than **13 July 2009**.

The ADG will verify all entries to ensure that they meet eligibility requirements.
